# **EQUESTRIAN CANADA STATEMENT OF PRINCIPLE**

Equestrian Canada (E.C.), the national federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

Equestrian Canada is committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities:
- Requiring that horses be treated with kindness, respect and the compassion that they deserve, and that they never be subjected to mistreatment;
- Ensuring that owners, trainers, exhibitors and their agents use appropriate care and responsibility in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose;
- Providing for the continuous wellbeing of horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety;
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions and;
- Reviewing, revising and developing competition rules and regulations that protect the welfare of horses.

In determining whether conduct or treatment is cruel, abusive or inhumane, the standard to be applied while will be the conduct or treatment expected of a reasonable person who is informed and experienced in equine training and exhibition procedures.

Individuals who interact with horses must also adhere to Equestrian Canada's policies as they relate to horse welfare.



# **EQUESTRIAN CANADA General Rules & Regulations**

Every class offered herein, which is covered by the rules and regulations of the current rules of EC and will be held and judged in accordance with the EC Rule Book (A602.2). All questions not covered by these rules shall be decided by the show management, whose decision will be final.

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person(s) responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition (A602.7).

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments (A602.9).

Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location (A602.5).

All horses attending Equestrian Canada sanctioned competition must have been administered Equine Influenza and Equine Herpes Virus (1 & 4) vaccinations within in 6 months (+21 day grace period) of the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave the event site at the discretion of the Competition Management. Competition Management may request supporting documentation confirming horse's compliance with mandatory vaccination requirements". See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.

A protest at an EC sanctioned competition other than those specific matters covered in division rules must comply with the following provisions: a) a protest is eligible only if made by an officiating judge, and owner, lessee, trainer, coach competitor or authorized agent, in the division in which the question arises; b) a protest must be made in writing and addressed to the Show Secretary; c) must be signed; and d) must be accompanied by a deposit of \$107 in cash. For full details see rule A1204 General Regulations.

#### THE CADORA-ONTARIO TEAM COMPETITION



CADORA-Ontario is pleased to announce that the 2022 Silver Dressage Championships will host a Team Competition.

With a view to encouraging more participation, those CADORA-Ontario members who compete as individuals at either division of the Silver Dressage Championships are invited to form "teams" and compete together for ribbons and/or product prizes and prize money (all contingent upon the acquisition of same).

### Rules governing this Team Competition are as follows:

- 1. All riders of all teams must be members of CADORA-Ontario (as of July 1, 2022).
- 2. No additional entry fees are required to enter teams.
- 3. There is no limit to the number of teams that can be fielded by any one CADORA group and/or individuals at either division.
- 4. All horses and riders may join only one team. A rider may join only one team within his/her division (Eastern/Western).
- 5. All team riders must compete in their relevant technical classes.
- 6. It is recommended that each team identify itself when making entries for the Silver Dressage Championships; however, teams can also be formed and identified at the Championships before the competition begins.
- 7. Each team will consist of three horse/rider combinations.
- 8. All teams entered MUST provide a team name (e.g. London Ladies).
- Any changes to a team (once identified) must be communicated to the respective divisional Show Secretary ASAP (before competition commences).
- 10. The higher individual technical score of each of the three team members will be added together to determine team placing. (Freestyles are not part of the Team competition)
- 11. Prize money, awards, etc. will be presented at the subsequent CADORA-Ontario Annual General Meeting to all members of those teams that finish 1st, 2nd and 3rd in each Division.
- 12. All riders of the first place teams, East and West, will be listed on the CADORA-Ontario Roster of Riders with their team name.
- 13. Please email the CADORA-Ontario Team Competition form separately to the Show Secretaries for the Eastern and Western Championships.

#### **ENTRIES**

i. Entries must be signed by the Person Responsible (A801.5) who must be an EC Sport License holder (A801.6). According to A213.2, parents and guardians must sign the entry form of a minor child/junior competitor; parents/guardians do not have to be EC Sport License holders Note, however, that the horse owner must hold a valid EC Sport License.

- iii. Incomplete entries will not be accepted by Compete Easy. Therefore, please ensure that you fill out all fields and attach all required documents.

Please contact the Show Organizer in the event of any emergency so that we can ensure access and care as required. An emergency plan with all relevant phone numbers will be posted at the registration desk and with the announcer.

Stabling

All stabling must be booked in advance for each competition. Please contact <u>b.westar@gmail.com</u> for Westar and <u>caledondressage@gmail.com</u> for Angelstone.

Stabling will be arranged on a first request basis.

No stabling refunds will be provided after the show closing date under any circumstances.

At Westar Farms, stabling is \$65 for Day Stall, \$85 for One Night Stall, Friday – Sunday, \$175 Shavings (\$8.25/bag) and hay (\$12/bale) may be purchased in advanced. Please bring your own feed and water buckets as these will not be provided.

At Angelstone, stabling is \$120 for the weekend + \$50 cleaning fee [if required], shavings are \$8.00/bag and must be ordered when booking a stall. Please bring your own feed and water buckets as these will not be provided. If you require a tack stall, please contact the organizer to see if any will be available. Stall Cards are required for your horse and contact information.

#### **Conditions**

- 1. Every class offered is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book; competitors are responsible for knowledge of these rules.
- 2. The show committee reserves the right to govern all conditions of the show.
- 3. Neither Caledon Dressage, CADORA-Ontario, the show committees, nor the facilities (Westar Farms and the Angelstone Tournaments) will be held responsible for any damage, injury or loss to persons, animals, vehicles, trailers or other property of exhibitors or spectators.
- 4. This competition is a Championship. Refer to the current year **Rules of Equestrian Canada**. **Sections 7.24 through 7.30 relate to CHAMPIONSHIP competitions ONLY**.

A reminder that Hors Concours entries will not be permitted.

- i. **ARTICLE E 7.11.12 SCHOOLING OF HORSES/PONIES** 3. At Silver and Gold Championships, schooling of horses/ponies may be done **only** by the competing athlete from his/her arrival on the show grounds until his/her last class ridden, under penalty of elimination. A groom mounted in the saddle may walk the horse/pony on a long rein. Note: for Para Equestrians riding PE tests see Chapter 6 Para Equestrian.
- ARTICLE E 9.1 CALLING TESTS All EC tests Introductory through Fourth inclusive may be called during the competition except for championship classes at Gold and Silver Championships when all tests must be ridden from memory
- iii. **ARTICLE E 9.5 ELIMINATION FROM A CLASS** An entry shall be eliminated under the following circumstances: carrying a whip into the competition arena at any EC Championship. Riders may drop the whip before entering the competition arena at the letter A.
- 5. No one other than the competing rider may school the horse from the moment it arrives on the show grounds to the end of the last class ridden.
- 6. A current valid Horse Recording number must be provided with the entry before competition numbers will be issued and the horse is allowed to compete
- 7. From the moment the horse arrives on the show grounds, all EC rules and regulations apply.
- 8. Competition numbers must be worn at all times that the horse is out of its stall or trailer.
- 9. In accordance with Dressage Rule E.7.28, all levels will be offered as categories (except where indicated) of Open, Junior and Amateur.
- 10. All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear at all times when mounted at any EC-sanctioned Dressage competition at the event location. Protective headgear must be certified under one of the following standards: ASTM (American Society for Testing Materials), or SEI (Safety Equipment Institute, Inc.); BSI/BS EN (British Standards Institution); EN (European Union Standards; AS/NZS (Australian/New Zealand Standards; or CE VG1 01.040 2014-12.
  Note: At the tack check which follows the test, the steward may ask the rider to dismount so that the helmet may
  - Note: At the tack check which follows the test, the steward may ask the rider to dismount so that the helmet may be inspected for the above approved standards. [Dressage rule 4.0]
- 11. Judges' and Stewards' decisions are final.
- 12. All riders must report to the Steward immediately following their tests for a tack check. Failing to report will result in elimination from that class. In the event of random tack checks it is the responsibility of the rider to check with the Stewards if they have been selected. Dressage Rule E. 4. 16.
- 13. All tests will be ridden in the 20x60 ring.
- 14. All freestyle music must be provided via email prior to the show. Only digital copies are accepted and must be provided electronically. In accordance with EC rule E 10.3.4, two functioning copies of music must be submitted.
- 15. Stabling is to be arranged as per each division's instructions. See page 7.
- 16. Non-competing horses are not allowed on the show grounds.
- 17. Any horse on the show grounds is subject to random drug testing. Failure to comply will result in elimination from competition and disciplinary action from EC.
- 18. Lunging will be available at both competitions. Please see the Show Secretaries.

#### **Qualifying Criteria/Eligibility**

- 1. To qualify for the Silver Dressage Championships, a horse/rider combination must compete in a minimum of two competitions (1 day or multiple) and earn two scores of 55% or higher at two different competition days (from the same or different judges) at each level to be entered (including FEI).
- 2. Shows/Competitions definition a show or competition may run 1 day or multiple days and be a sanctioned event with Equestrian Canada.
- 3. Both riders and owners must be members in good standing with PSO and hold an EC Silver Sport License or higher.
- 4. All horses must have a current EC Horse Recording.
- 5. To qualify for the Silver Dressage Championship freestyle classes, a horse/rider combination must have competed in a minimum of two Silver competitions and earned two scores of 55% or higher in freestyle classes at different competitions (from the same or different judges) at each level (including FEI).
- 6. In the event that class sizes must be limited, classes will be filled in descending order of the total of the technical qualifying scores submitted.
- 7. In the event that there are insufficient entries received, additional entries will be accepted (first come, first served) provided the horse/rider combination has competed in two Silver competitions at each level to be entered and has attained scores of 50% or above.
- 8. Horses may compete with two different riders at two consecutive levels if each horse/rider combination has qualified at the appropriate level.
- 9. Horse/Rider combinations may compete at two consecutive levels but in only one freestyle level.
- 10. No substitute riders are allowed

#### Examples of ways to qualify

1 - Ride at two 1 day competitions – rider competes in 2 classes at each competition = 4 scores Scores from first competition are 56% & 58%

Scores from second competition are 63% and 57%

Rider would qualify with 58% from competition 1 and 63% from competition 2.

2 – Ride at 2 multiday competitions – rider competes in 3 classes at each competition on three different days = 6 scores. Scores from first competition are 54%, 50%, 57%

Scores from the second competition are 60%, 62% & 56%

Rider would qualify with 62% and 60% from the  $2^{nd}$  Competition as well as having competed in the  $1^{st}$  Competition (2 Competition ruling).

Rider would not qualify if they only competed in Competition 2.

3 – Ride at 1 single day competition and at 1 multiday competition—rider competes in 3 classes at the single day competition and the rider competes in 5 classes on three different days at the multiday competition = 7 scores. Scores from the single day competition are 65%, 63% & 66%

Scores from multiday competition are 58%, 60%, 64%, 63%, 64%

Rider would qualify with 66% from the single day competition 64% from the multiday competition.

Rider would not qualify if they only competed in the multiday competition.

Rider could also qualify if they wanted to use the scores from the multiday competition fulfilling the 2-competition ruling.

#### **Entries**

- 1. Competitors may enter either the Eastern Division or the Western Division, but not both.
- 2. Competitors may not enter a freestyle class without entering the technical test classes at the same level and in the same division.
- 3. Every entry must be accompanied by:
  - a. A signed liability waiver form including a "Person Responsible" authorization (on entry form). Entries must be signed by the Person Responsible (A801.5) who must be an EC Sport License Holder (A801.6). According to A213.2, parents and guardians are entitled to sign their children's entry forms without being EC members or license holders. Note, however, that the horse owner must hold a valid EC Sport License. Please see page 3 of this prize list for more information on the PERSON RESPONSIBLE.
  - **b. WESTERN DIVISION ONLY:** A photocopy of a current year membership of a provincial equestrian federation and an EC Competitive License for both owner and rider
  - **c. EASTERN DIVISION ONLY**: A scanned copy of the current year negative Coggins test for each horse being exhibited.
  - **d.** Current year horse recording for the horse being exhibited.
  - **e.** Scanned copies of the tests indicating the show name, date, class, division, judge's name, judge's signature, and qualifying score (cover page only is acceptable).
  - f. Scanned copies of current vaccinations for EVH 1 & 4 and Equine Influenza vaccinations.
- 4. Entries must be received by the applicable closing date with all required information, and payment in full in order to be accepted.
- 5. Payments made after the closing date will not be accepted.
- Payments will be made as follows:
   Eastern Championships Payment via Credit Card through Compete Easy or via e-transfer to <a href="mailto:b.westar@gmail.com">b.westar@gmail.com</a>.
   Western Championships Payment via Credit Card or PayPal through Compete Easy.
- 7. Competitors will be charged \$50.00 for any payments returned for any reason from the bank.
- 8. Refunds will be made in full, minus the administration fee, upon receipt of written notification up to the closing date.

  After the closing date, no refunds will be issued for any reason. Stabling is non-refundable after closing date.
- 9. PLEASE NOTE: Add-on classes will NOT be offered at either Division of this competition.

#### **Awards/Results**

- 1. Awards are based solely on the results of the Division classes. See Article E.9.9, Scores and Placing (page 77 of the EC Rule Book) as it pertains to single entry scores.
- 2. Class ribbons will be awarded to 8th place. Prizes will be awarded to those who place in accordance with sponsorship received.
- 3. Should there be two judges for a class, the class score shall be the average of the two scores obtained from the judges.
- 4. Details on presentation of awards will be posted on the day of the show. If presentations are mounted, horse and rider must be dressed appropriately and competitive numbers must be visible. For unmounted presentations, riders must be dressed appropriately. Non-compliance may result in forfeiture of any and all ribbons, awards and prizes for the class.
- 5. NOTE: If a competitor is in disagreement with his/her test results, or has other significant problems, he/she must bring it to the attention of the Show Secretary/Manager for discussion with the Steward and Judges before the show closes. The show will close thirty (30) minutes after the last test of the day has been completed.
- 6. Championships will be awarded at each level (Introductory through Advanced) in Open, Junior and Amateur (except where indicated). Championships are determined by the total percentage of the two technical tests. The competitor with the highest total shall be declared the champion of his/her level and category (e.g.: Training Level, Junior, etc.) and the competitor with the second highest total shall be declared the reserve champion.
- 7. Freestyle Championships will be awarded at each level (Training Level Intermediate II) as an Open division only.
